Archival of Diabetes Associated Requisitions and Replacement Laboratory Requisitions To Be Used

Date issued: January 9, 2023

Date effective: February 13, 2023

As of Feb 13, 2023, several outdated laboratory requisitions will be archived and if necessary, replaced with current provincial requisitions. The EMR systems have already received all necessary requisitions and will move to archive/remove the old requisitions on the aforementioned date.

The new requisitions will be implemented with a phased in approach and must be used by Feb 13, 2023 and will include a two-week reminder email about the change.

If after Feb 13, 2023 a health-care provider continues to use the outdated requisition, the following process will occur for a **two-week timeframe only:**

- ❖ Lab staff will contact the physician responsible for the sample by phone indicating the wrong requisition has been sent with the patient sample
- ❖ Lab staff will provide the physician with a fax number of the lab upon which the correct requisition with all of the patient demographics and tests is to be sent
- ❖ If the requisition is not sent within 1 hour of phone call, the sample will be rejected due to sample quality concerns (Chemistry specimens must be centrifuged within a certain timeframe or the sample quality is deemed unsatisfactory)
