

Expansion of Manitoba's Primary Care Quality Indicators (PCQIs)

Once certified to the PCQI v5 specification, your Certified EMR will provide new alerts and reminders for additional PCQIs as outlined below. Alerts and reminders can support providers with understanding when patient care aligned to the PCQIs is:

- Soon to be due (within 90 days of the recommended timeline);
- Overdue (past the recommended timeline); or
- Completed (within the recommended timeline).

For each condition, the applicable and recommended ICD-9 code(s) must be captured in the EMR to support triggering the patient care alerts and reminders. More information on diagnosis codes is available on Manitoba Health's website in the <u>Chronic Disease Clusters – ICD Code Resource</u>. In addition, your vendor can provide support on configuration in your EMR to support submission of indicator completeness to Manitoba Health via the Primary Care Data Extract (PCDE). Additions in the Mental Health category:

- ADHD
- Bipolar Disorder
- Schizophrenia
- Borderline Personality Disorder

New Sexually Transmitted and Blood Borne Infections (STBBI) category:

- PrEP
- HIV
- Syphilis
- Hepatitis B / Hepatitis C

Updates to existing PCQIs:

- Updated age criteria to 65+ for Pneumococcal immunization
- Addition of vaping to smoking status, smoking cessation counselling, risk screening and spirometry indicators
- Inclusion of cannabinoids in ongoing assessment and management of Substance Use Disorder (SUD)
- Updated terminology for Colorectal Cancer and Pap tests

Increased Client Summaries in eChart Manitoba

As of December 2024, 195 primary care Home Clinics can send a Home Clinic Client Summary to eChart. This includes all regional primary care sites and an expanding number of fee-for-service practices across the province.

A Client Summary enables a health-care provider outside the Home Clinic to access clinical information to support continuity of care for an enrolled patient. By sharing primary care information with eChart, a health-care provider located in areas such as an emergency room, urgent care department or walk-in clinic can access the information needed to inform care coordination at the right time. On average in 2024, over 1800 Client Summaries are accessed monthly by authorized providers in eChart. Learn more about them in our <u>Info Sheet</u>.

A Client Summary is a document stored in eChart that contains a standard set of clinical information on an enrolled patient as provided by primary care Home Clinic's Certified EMR, including:

- Patient demographics
- Home Clinic details
- Health Conditions and Diagnoses
- Surgeries, Procedures, and Interventions

- Suspected Allergies and Intolerances
- Prescribed Medications
- Vital Signs
- Client Summary Comments

Updated Manitoba Prenatal Record

Manitoba's Prenatal Record has been updated following provincial consultation across multiple disciplines, including obstetrics, midwifery, and nursing, and has been reviewed by the Women's Health Provincial Clinical Team. The new form has been developed to ensure consistent practice across the province and to reflect best practice in prenatal care. The updated form is available for immediate use and ready for implementation in your organization as soon as reasonable. Vendors of Manitoba Certified EMRs have received the updated form.
