Cumulative Blood Product Record (CBPR)

Patient Consent/Verification of Product:

- Verify that consent for transfusion has been completed by physician*
- Treating practitioners verify at patient's bedside (2 initials required)*
 - identity of patient
 - correct blood product

Assessment for Suspected Transfusion Reaction:

- If patient is not symptomatic document "N" and proceed with transfusion.
- NEW onset of symptoms following initiation of product:
 - Temperature rise greater than 1 degree Celsius
 - Dyspnea/Hypoxemia
 - Tachycardia
 - Hyper/Hypotension
 - Bleeding at IV site
 - Chills/Rigors
 - Urticaria/Pruritus
 - Jaundice
 - Hemoglobinuria
 - Pain (location)

Document "Y" in suspected transfusion reaction section, proceed to the Transfusion Reaction Algorithm, and document in the patient record any symptoms, actions or interventions.

Blood Products:

- RBC:** Red Blood Cells
- Plasma:** FP24 or AFFF
- PLT:** Platelets
- HSA:** Albumin
- CRYO:** Cryoprecipitate
- RhIG:** WinRho®
- IVIG:** Intravenous immune globulin
- PCC:** Prothrombin complex concentrate (i.e. Octaplex®)
- F/rF:** Factor/recombinant factor
- SCIG:** Subcutaneous immune globulin
- HBIG:** Hepatitis B immune globulin
