

# Finance Proxy Accounts Reference

## Overview

Authorized representatives from Finance can use SuccessFactors to display details for job requisitions associated with their site/business area.

These users must proxy into the generic Finance account for their site/business area to access associated job requisitions.

## Finance Requisition Proxy Accounts

The following table identifies:

- **Finance Proxy Account ID:** the ID to be entered when proxying the generic Finance account in SuccessFactors.
- **Generic Account User ID:** the user ID that must be entered to access the generic account for the purpose of assigning and deleting Finance proxy users. This must be completed by the generic account owner at the following link <https://hcm17.sapsf.com/login#/login> (use Company ID *winnipegHCP* if prompted).
- **Corresponding Site/Business Area:** the corresponding site(s) and business area(s) for each Finance Proxy account.
