- Ensure healthcare models reflect Northern communities' unique needs.
- Break down systemic barriers impacting Indigenous healthcare.
- Foster inclusive, culturally relevant healthcare practices.
- Create sustainable healthcare initiatives through local partnerships.
- Prioritize community-centric planning for health equity.

#### **Critical Success Factors**

Key factors that will determine the success of initiatives that involve the North

- **Early Engagement**: Collaborate with NCWT from program inception to align with Northern needs.
- **Cultural Integration**: Respect and integrate Traditional Healing practices and Healers.
- ❖ Innovative Models: Use integrated teams to include Northern experts in planning.
- ❖ Data-Driven Planning: Collect and analyze data to shape sustainable healthcare models.
- **Collaborative Partnerships**: Build relationships across all levels for program success.

#### **Lessons Learned**

Insights gained from working with Northern communities

- **Community-Centric Models:** Involve Northern experts in planning stages to ensure alignment.
- **Culturally Informed Care**: Integrate Indigenous principles to create welcoming spaces.
- ❖ System-Wide Collaboration: Success requires dedication across all planning levels.
- **Long-Term Commitment**: Consistent engagement is vital to build trust and effectiveness.
- Flexibility in Approaches: Adapt strategies based on community feedback and evolving needs.
