Change Summary	<p>This Change Request is related to an upgrade to the provincial Electronic Health Record, eChart Manitoba (eChart 2022).</p> <p>The change involves updates to the Specification and Assessment Guide for the eChart Manitoba Context-Sensitive Launch Interface.</p> <p>This change will be mandatory to maintain existing or achieve new EMR Certification in Manitoba.</p> <p>The deadline for certification to this change is July 29, 2022.</p>

Reason for Change	<p>The eChart Manitoba Context-Sensitive Launch Interface allows an EMR User to execute a context-sensitive launch of an eChart Manitoba record using client demographics from an EMR record that an EMR User had accessed.</p> <p>The new eChart Manitoba (“eChart 2022”) upgrade includes additional display and configuration changes including providing users with the ability to personalize their display preferences, view items by reverse chronological order, and set and save other personalization configurations.</p> <p>Microsoft Internet Explorer version 11.0 will be unsupported as of June 15, 2022, and there is a need to update eChart Manitoba along with the “eChart Manitoba Context-Sensitive Launch Interface” to a supported browser.</p> <p>This upgrade will require the use of new parameters to invoke the eChart Manitoba Context-Sensitive Launch and will rely on the following supported web browsers:</p>

Implications of not implementing change	<p>As this component is foundational to Standard level certification, EMRs are required to complete certification to the upgraded specification to maintain Manitoba EMR Certification status.</p> <p>The existing eChart Manitoba Context-Sensitive Launch interface will be phased out. EMR Vendors will be made aware of the date at which point the existing eChart interface will no longer be available.</p>
